In June, the trustees of Miami University (Ohio) approved contracts to demolish Van Voorhis Hall despite pleas from preservationists who had lost an appellate court decision in the case.

The 89 year old gymnasium is on the National Register of Historic Places and is under consideration for designation as a National Historic Landmark. The building's use in training coaches is partly why Miami is known as the "Cradle of Coaches" according to trustee William G. Davis, the lone dissenter in the contracts resolution.

GUEST SPEAKER

The Guest Speaker will be Mr. Peter Christoph, Director of the New Netherlands Project. Mr. Christoph will be discussing the Project, which is an effort to translate the early records of Nieuw Amsterdam, which are housed at the New York State Library. Due to the shortage of workers trained in reading the Old Dutch in which the records are written, they are now virtually useless to the average researcher. The Project, when completed, will make these important early records available to all whose research lies in the early years of settlement in the Mid-Atlantic States. Special emphasis will be placed on the records which pertain to Steved Coerte and his early descendants.



Minutes of the 53rd Annual Meeting
Van Voorhees Association
12 October, 1985
Jane Voorhees Zimmerli Art Museum
Rutgers University
New Brunswick, NJ

The 53rd Annual Meeting of the Van Voorhees Association was called to order at about 1:50 p.m. by President Donald Vorhis. The Rev. William Lydecker gave the Invocation; and Alice Voorhees Adams spoke briefly about the history of the Art Museum which was endowed by, and named after, her mother.

Frank Van Voorhis, Planning Committee Chairperson, displayed the ceramic tiles bearing the Van Voorhees coat-of-arms, and announced that they would be on sale after the meeting.

Art Voorhees, Membership Committee Chairperson, announced that we gained 70 new members this year. President Vorhis led a round of applause for our 6 Lifetime members; and then gave prizes—a pin with a tiny pair of wooden shoes, and a pin with a Dutch windmill—to the new member who had come the farthest and to the old member who had come the farthest.

Mildred Voris Kerr gave a short presentation of the upcoming 3rd Annual Van Voorhees trip to The Netherlands, whose highlight is a visit to the ancestral farm at Hees.

Bob Voris, Publications Committee Chairperson, was greeted by cheers as he announced the publication of The Van Voorhees Family: vol. 1. The long-awaited, and often despaired-of, genealogy has finally been printed! Bob announced that 800 copies of the soft-bound edition have been delivered, and some will be available for sale, after the meeting. The 800 hard-bound copies are expected within a few days; and shipping of orders will begin immediately

Bob then thanked the many Association members who have assisted him; and introduced Albert Stokes, the VVA Association genealogist, who displayed a copy of a deed bearing the signature of Lucas Van Voorhees.

The reading of the Secretary's Minutes of the 52nd Annual Meeting was suspended by motion and vote.

The Treasurer's report was given by Treasurer, G. Harold Buttler, as follows:

President Vorhis then called on selected Committee Chairpersons to give brief reports:

Publicity Committee Chairperson, June Wick, noted that our high-powered publicity campaign is attracting many new members; and called on all members to "spread the word." She gave formal thanks and recognition to her committee members, Candace Voorhies and Darlene Vorhies.

Membership Committee Chairperson, Art Voorhees, announced that the membership list has finally been organized by state, as requested; and that that information is available.

Newsletter Co-Editor, George Davis, announced that the Newsletter will be published on a new schedule to facilitate the inclusion of announcements about annual events: January, April and July are the new dates.

President Vorhis then called for a general vote on the proposed revision of the By-Laws. Since no discussion from the floor was forthcoming, the vote was taken and the new By-Laws unanimously approved.

The Secretary here notes that 77 absentee ballots were returned, and the By-Laws approved by a margin of 74 to 3.

President Vorhis then turned the meeting over to Vice-President, Donald Sinclair, to conduct the election of officers. Nominating Committee Chairperson, Cornelia V. Mason, announced the slate of officers, each to be elected for a 2-year term, proposed by the Nominating Committee:


for President, Donald G. Vorhis for Secretary, Candace Voorhies for Treasurer, G. Harold Buttler

Vice-President Sinclair asked for nominations from the floor; and, as none were forthcoming, Bob Voris made the motion that the officers be elected by acclamation. The Rev. William Lydecker seconded the motion; and said slate of officers was unanimously elected.

The Secretary here notes that the 77 absentee ballots were unanimous in their approval of the said slate of officers.

President Vorhis, after succeeding himself as President, displayed a football jersey imprinted with the name "VOORHEES" and the number, "1;" and remarked that he felt it incumbent upon himself to begin the tradition of passing this item along to his successor! We all hope Don will be wearing this badge-of-office for a very long time.

As acting Chairman of the Program Committee, Art Voorhees introduced our main speaker, Captain Richard Z. Voorhees, of the Bridgewater Police Department, whose "Operation Home-Free" program has received national commendation. Captain Voorhees gave a most interesting and inspiring talk on this program which, since April 1984, has given over 6,000 runaway kids transportation home, free of cost, via bus. The program is underwritten by the International Police Chief's Association and Trailways, and appears to be a model of cooperation among police departments all over the country.



The original Dutch claims in the New World stretched from the shores of the Delaware Bay north to present day Albany, then known as Fort Orange and east into Long Island, including most of Nassau County. It also included all of New Jersey. The earliest settlements were the trading posts at Fort Orange and at Nieuw Amsterdam (New York). The British and Spanish colonies were established as extensions of the mother country, to be exploited certainly but always with the intention of populating and "civilizing" the wild new land. The Dutch colony, by contrast, was intended solely as a trading establishment, to reap the bounty of the land (furs, timber, minerals) and nothing else. However, to support these trading activities, it soon became apparent that a military presence was necessary for protection both from the natives, as well as the neighboring empire builders. To support the military and growing administrative and trading centers, satellite farming communities, first uptown in Manhattan, then across the East River in Brooklyn and across the bay in Staten Island.

As the population and demand for land grew, the communities reached even further afield. New Jersey's fertile land and close proximity to Nieuw Amsterdam drew many Dutch farmers looking for a place to settle. The area near New Brunswick, being close to the mouth of the Raritan River, and the nearby Millstone River valley were among the areas favored by these settlers. New Brunswick also had the advantage of a relatively good harbor, and became a trading center for the area, and point of shipment for produce from the Raritan and Millstone valleys to Nieuw Amsterdam.

Among the early settlers of the New Brunswick area were many Van Voorhees, and the area is still home to many descendants. Over the past three centuries many sites in the area have been associated with the family. Some of these are listed below, and located on the map which follows, for anyone who wishes to visit. All are within an easy drive of New Brunswick, through a part of the state which is still relatively undeveloped despite its close proximity to New York City.

- 8. Abraham and Neeltje Cortelyou Van Voorhees farm- Abraham settled here in 1726. He was the youngest son of Lucas Stevense and Jennetje Minnes Van Voorhees. Their son Jacques imported wine from Madeira with Col. John Neilson.
- 9. Site of Lucas Van Voorhees Mill-Lucas was a son of Abraham and Neeltje Cortelyou Van Voorhees.
