COMMITTEE REPORTS

. Historical Committee

The first draft of the report on the results has been received, and is presently being revised to incorporate the latest research. As previously reported, the information sent to date by Drs. Life member DAVID WILLIAM VOORHEES received his Doctorate in History from New York University on April 26, 1988. David's thesis dealt with what is popularly known as "Leisler's Rebellion" of 1689-91. He spoke about Jacob Leisler at the Conference on New York State History at Colgate University on June 10.

David's mother IRMA (Mrs. William F.) **VOORHEES** was recently appointed historian of the Princeton (NJ) Women's Club.

BERNARD V. (Barney) WARD, son of life member VIRGINIA V. and Joseph WARD, was married on Oct.24, 1987 to Zsuzsanna Judit Roman. The ceremony was performed at the Magyar Reformed Church of New Brunswick, NJ, followed by a reception at Colonial Farms, the historic Garrett Voorhees homestead in Somerset. NJ.

QUESTIONNAIRES

Thank you for the excellent response to the questionnaires which appeared in the last Newsletter. The information from the genealogy forms is now being added to our computer files for reference by the Association Genealogist and for general research in answering queries. The file now contains well over 2,000 names, and is growing rapidly. The historic house/site forms are being collected together, and the information will be reduced into a usable format.

We have received a number of inquiries from members as to what information is really needed on the genealogy forms. The Family Group Record form (p. 9 of the Newsletter) should be filled out for yourself as a minimum. We request that, if possible, you complete additional forms for your children, grandchildren, parents, siblings, cousins, aunts, uncles, grandparents, etc., for as many generations as you can. There is no need to go beyond information which is published and generally available.

The Ancestor Chart (p. 10 of the Newsletter) should be completed with yourself as number 1, and following at least your Van Voorhees line, with as many additional generations as you can, back to the generation shown in Volume 1 of the Genealogy, if possible. Please include the number of the person as listed in the genealogy. It is important that you provide enough information to connect to the early generations, if possible, to maximize the usefulness of the information. Also, please include your member number on the forms.



THE ARRIVAL OF DOMINE POLHEMUS IN AMERICA, 1654 Marie (Mrs. Theodore B.) Voorhees

Johannes Theodorus Polhemus was born 1598, probably in the Rhenish Bavarian Palatinate. A Heidelberg University graduate of divinity, 1620-24, he served briefly in the Palatinate; then in the Netherlands, Province of Drenthe, including seven years at Meppel.

He became a part of a large Dutch expedition to Brazil that sailed from Amsterdam 26 Oct. 1636, to establish Dutch colonies after conquering the Portugese at Recife, arriving there 23 Jan. 1637.

Final distribution of the colonists was made in 1638, and the Rev. Polhemus became minister on Itamarca Island, adjacent to Recife. He married ca. 1643 Catherine Van der Werven, and his first four children were born at Itamarca. Because of insurrections there, he lost his plantation, and was forced to return to Recife ca. 1648.

Eventually the Dutch were forced out of Brazil 25 Jan. 1654. In April 1654, sixteen Dutch ships were in the Recife harbor to evecuate the Dutch citizens and others. For some reason the Rev. Polhemus and his wife and children took separate ships. Fifteen of the ships arrived safely in Holland, including the one with Mrs. Polhemus and their four children.

If the sixteenth ship, carrying the Reverend had not met with misadventure, there probably would never have been a Polhemus family in this country.

Rev. Folhemus arrived at Nieuw Amsterdam in September 1654 on the French Man-of-War "St. Charles", according to A. Biet's "Voyage de la France Equinoxale". The Dutch ship on which he had left Brazil was captured not far from Recife by a Spanish pirate. Shortly thereafter, near Barbadoes, the privateer with its prize was in turn captured by the French.

Two years later, 4 Sept. 1656, the family of the Rev. Polhemus arrived in Nieuw Amsterdam on the ship "Gulden Otter" from Holland. The Polhemus family was again united.

ed. note: The above story of the arrival of the Polhemus family in America was reduced from information compiled by Helen Brokaw Macon, in her book "Brokaw - Gibbs and Allied Families", 1984. In addition to several marriages between Polhemus and Van Voorhees descendants, there is evidence that Domine Polhemus may have had closer connections to the Van Voorhees family than previously thought. It is probable that the Domine and Steven Coerte resided in the same general area of Holland prior to the Domine's emigration to the New World, and that, even if Steven did not personally know the Domine, that he at least knew of him. Circumstantial evidence

indicates that one of the Rev. Polhemus sons married a sister of Willempie Roelofse Seubering, second wife of Steven Coerte. Correspondence from the Rev. Polhemus to friends and relatives in Drenthe was probably a factor in the migration of a group of more than 100 Drenthe residents, including Steven Coerte, to America.

In Memoriam

J. RUSSELL VOORHEES passed away at his home in Tallman, NY on April 15, 1988 at age 85. He retired from Curtiss-Wright Corp., where he had worked for 40 years, in 1964. Mr. Voorhees is survived by his daughter, June V. Wick, and 2 grandchildren.

Dr. WILLIAM DELANO VOORHEES, Jr. died Nov. 22,1987, age 66. He received his M.D. from Johns Hopkins University in 1945. He was an instructor at the University of Washington, Director at Western State Hospital, Superintendant of Northern State Hospital (WA) and First Deputy Commissioner of the New York State Dept. of Mental Health. He retired as Director of the Forensic Unit at Western State Hospoital, Tacoma, WA in 1982. A retired Captain of the U.S. Army, Dr. Voorhees was a diplomat of the American Board of Neurology and Psychiatric Assoc. Dr. Voorhees is survived by his wife, Selma (Schurmann) Voorhees, a son, two daughters and three grandchildren.

STUART CHAPIN VanVOORHEES, 78 died April 9, 1988. A native of North Tonawanda, NY, he moved to Orlando, FL in 1953, where he retired as instructor and director of the Orange County Vocational School. He was a member of Iota Lambda Sigma Vocational Fraternity, life member of the American Vocational Association, and past president of the Florida Vocational Association. He is survived by his wife, Marty, a son, three stepchildren, three grandchildren and a sister.

ORVILLE S. VOORHEES of Toms River, NJ passed away recently, age 83. A draftsman at the Wood Newspaper Machinery Co., he retired in 1970. He was a member of the Old Guarde, Tom's River, Washington Valley Fire Co., serving as its treasurer for 25 years, and Warren Twp. Exempt Firemen's Assoc. Mr. Voorhees was a member of the VanVoorhees Association since 1932. He is survived by a daughter, a brother, two grandsons and two great-grandchildren.
