# 56th Annual Meeting

Guest speaker Harriet Stryker-Rodda gave an interesting talk encouraging us to try a new approach to genealogy, by deliberately leaving clues to future researchers about ourselves. (see below).

Following the meeting, Rev. Muyskens, minister at the Church, gave a tour of the church and churchyard, for those interested. Steve Shyers provided a demonstration of our computer genealogy system, as well as sharing of genealogical information for several of the members. And the ladies of the church came through again with a host of delicious goodies which disappeared during the post-meeting renewal of family ties which has become the traditional closeout of our annual meetings in recent years.

YOU

In her talk at the annual meeting, guest speaker Harriet Stryker-Rodda pointed out that each of us is an historical person. Just as we today seek to find information about our ancestors, our descendants will do the same, and the people they will be looking for is us i.e. YOU. Why not start a new approach to genealogy by deliberately leaving clues to your descendants, so they will be able to know you?

Picture your hand as a genealogical tree, with your fingers representing five generations. With your middle finger representing yourself, your index finger is your parents, and your thumb is your grandparents. Similarly, your ring finger is your children, and the little finger is your grandchildren. What do you know about your parents and

grandparents? If you think about it you will probably find that it is very little, mostly what your parents could or wanted to tell you. on that, what will your children and grandchildren know about them -- or even yourself? In just 8 generations, you are descended from more than 500 Where will you show people. up if you haven't done anything about it. This is particularly so today, where our society has become so mobile.

Pass on your experiences! Leave clues!

What should you leave? This will depend on you, but here are a few suggestions:

Photographs (be sure to label them - who, when, where)

Documents - deeds, service certificates, membership certificates, school honors, diplomas

Precious letters
Newspaper clippings
Furniture and other items
which are important to you
Fabrics, shawls, etc.

Consider keeping a diary. does not have to be fancy, or in a bound book. Entries can be very brief, or more extensive if you prefer. Diaries can provide a wealth of information for future generations. As an example, Mrs. Stryker-Rodda cited the diaries of John Baxter, which were written in the years following the American Revolution. years later, they turned up on Long Island, and were transcribed to typescript by Mrs. Stryker-Rodda. Among other things, there are over 200 references to Van Voorhees in book 1 alone, some of which are cited below.

To be sure that the items you want preserved are passed to those you want to receive them, label the documents, books, and artifacts with a label stating. "I want this book (or whatever) to go to ..."

Instead of (or in addition to) being a searcher, turn yourself into someone who will be searched for!

## NEWS FROM CAJUN COUNTRY

Our Louisiana cousins have produced a line drawing print showing Judge Felix Voorhies (b. 1839) and his twelve children. Judge Voorhies served in the Confederate Army and was eventually appointed District Judge. On the side, he wrote music, plays and books. The most famous of these is "Acadian Remembrances" which tells, from first hand accounts, the story of the Cajun exile from Nova Scotia, and served as the idea for Longfellow's epic poem "Evangeline". Many of the Judge's descendants left Louisiana, and their descendants must be spread over the country. ### COMPUTERIZED GENEALOGY INFORMATION

As mentioned in previous Newsletters, the genealogical information in the Association's archives is gradually being entered into a computer-based filing system. The primary purpose of this is to speed access to the information to genealogical researchers. Finding individuals and identifying relationships is greatly eased when the computer does the tedious searching, particularly when there are (as in the case of our family) many individuals with the same name. It is our hope that, as the body of informa-

tion in the computer file grows, it will facilitate making connections for those whose lines to our common ancestor are missing a generation or two.

We believe that the file has grown to the point that this effort can be begun. Inquiries to the computer file will be accepted from anyone who has submitted family record and ancestral charts as requested in previous Newsletters. If you haven't yet submitted yours, please do. Please be as specific as possible in your request. The following types of reports are available:

- 1. Individual record
- 2. Family record
- 3. Ancestor chart (specify number of generations and person to be the youngest (most recent) on the chart
- 4. Descendants chart Please include remittance, payable to the Van Voorhees Association, with your request, as follows:
- \$ .50 per four pages (or part), to cover costs of paper, postage, etc.

Please note that individual records and family records require at least one page per record. Ancestor charts have four generations per page, but for a single line of more than four generations, the second and following pages will contain only three generations. Pedigree charts can run several pages, depending on the line and number of generations requested. Most of the information contained in the file has not, at this time, been verified from original sources, and we assume that there are some errors in the file. Until such time as the file has been proofed from original sources, assume that all information MUST be verified before being accepted as historical fact.

# **New Netherlands Project**

As previously mentioned in these pages, the New Netherlands Project, under the auspices of the New York State Library, is attempting to translate the Dutch documents of the Nieuw Netherlands colony. This project is financed primarily through grants and private donations. The goal is to eventually translate all of the 12,000 plus pages of documents in the Library's collection, as well as obtain and translate any other documents relating to the Dutch colonial period in the New York area. This work is important in the understanding of the early years of our family history in the New World, as most of the existing history of this period has been written based on the English records, which are prejudicial to the English point of view and incomplete with regard to daily happenings of the common citizen.
