From the President

The opportunity to meet with our Executive Committee is always stimulating and rewarding, as I've noted in this column repeatedly. But I want to share two items that came out of the most recent meeting.

First, the Committee was most anxious to have as our speaker at the fall general meeting Drs. Jan Folkerts, who has done such a fascinating job of researching our family history in the Netherlands under Association sponsorship. It was not at all clear, however, Drs. Folkerts could obtain the support from the Holland Society that would make possible his presence in this country this fall. What impressed me most was the determination of several key Committee members who were determined to cut through the roadblocks and get the Holland Society to act on Drs. Folkerts' proposal. The result is announcement in Newsletter that Drs. Folkerts will be the big attraction at our General Meeting on Saturday, 30 September. Mark your calendar now and try to be with us for this big event.

The second item is of quite a different nature, harking back to the fine presentation at our 1987 meeting by President

Dawson of Voorhees College. A number of us have felt bad that the Association was not in a position to give more support to President Dawson and his fine program at Voorhees College. The Executive Committee did some real soulsearching and came up with an offer of support most recently accepted by President Dawson. In essence this is a trial program of three years duration, in which we shall provide \$1000 per year from interest earnings to a student to be selected by Voorhees College authorities dual basis of (a) financial (b) demonstrated emulation of the character and philosophy of the school's founder, Elizabeth E. COMMITTEE REPORTS

Historical Committee

The most exciting news at the April Executive Committee meeting continues to be the progress being made with the in the Netherlands research archives on the roots of our common ancestor, Steven-The final draft report has been received from Drs. Jan Folkerts, and a combined historical/genealogical/publishing committee group

is in the process of editing the report for publication. Other efforts are also underway by this group to obtain publication permission additional related material to be included with the research report in an historical volume to be published in the near future. Chairman Manning and Publications Voorhees, Committee Chairman Bob Voris have had several meetings with the publisher to establish requirements for the manuscript. A volume of 150 plus

pages in format similar to the Genealogy volume I is anticipated.

The Executive Committee also determined that there will be one-time variation from bylaws requirements for term of office of the Secretary from two to three years, for the Secretary elected at this year's meeting. The VanVOORHEES LETTERS

As many of you are aware, the Association has several times published translations of four letters, which have become known collectively as "the Van Voorhees letters". In addition, a fifth letter was included in the 1888 Elias Van Voorhees genealogy. Since the time of the latest publication of the letters some 25 years ago, the whereabouts of the original manuscript letters had become unknown. The translations of the letters had provided some of the "starting point" information for the Folkerts research, and they are referenced in the research report. As part of the preparations for the report publication, it was decided that the letters would be included as addenda to the report. With that in mind, hopes were raised that the original letters could be located, particularly so that a scholarly translation of the fifth letter could be done, similar to those made for the four letters which have been published by the Association. Based on information provided by former Vice President Don Sinclair, Genealogy Committee Chairman Bill Lydecker volunteered to look for the letters at the New York State Library.

There, among the Tunis G. Bergen collection were the four letters.

Plus the fifth letter which had been in the 1888 genealogy.

Plus SIX more letters which were previously unknown to the Association. A potential treasure-trove of information which was completely unanticipated. To say that Bill was excited upon his return from Albany is an understatement. In addition, he has managed to arrange for the translation of the letters by Charles Gehring, translator for the New Netherlands project. The letters span a period of 45 years, with the most recent dated nearly seventy years after the emigration of Steven Coerte to the new world. The eleven letters are listed below:

Why are these letters so important? Proud as we are, and rightly so, of our VanVoorhees heritage, we are not Stuyvesants or VanRensselaers whose family papers have been preserved over the generations. To find so many letters from a family such as ours kept for so long is quite remarkable, if not unique. They give clues as to how the family lived and under what conditions were where they lived. They also give genealogical information, and help us to feel a bit closer to our ancestors. All in all, they reinforce our knowledge of our ancestry.

Winutes of the 56th Annual Meeting Van Voorhees Association First Reformed Church New Brunswick, NJ 8 October, 1988

Following a membership luncheon, the meeting was called to order at 1:45 p.m. by President Donald Vorhis. The oldest member present, Mildred Kavanaugh, was recognized, as was the youngest member, Jim and Mary Ward's new baby. Those travelling the longest distance were Dr. and Mrs. Harold Bird. Life members present at the meeting were also recognized, and President Vorhis introduced his Executive Committee.

He then talked about his desire to encourage more regional associations of VVA members, and called on Larry and Hazel Voris of Springfield, MO, to give a brief account of their attendance at Darlene Vorhies' annual reunion in Fairfield, IA, which about 75 people attended.

The business portion of the meeting then took place, with the reading of the Secretary's Minutes suspended by motion and by vote, all members having had a chance to read the printed Minutes in the Newsletter. No corrections being made, the Minutes were accepted as presented.

Art Voorhees, Membership Chair, reported that 57 new regular members have been gained this year, in addition to 6 new life members. This is 10-15 more than in past years. Also, four regular members have changed to lifetime status. The total number of regular members now stands at 514. With our life and junior members, the total membership of the VVA is now about 600.

Manning Voorhees, Historical Chair, reported that the research hired by the VVA in The Netherlands is now complete, and that we are moving into the publication stage. He also recognized members of his committee, Marie Voorhees and Jean Dones, for their help in information-gathering. His goal, he said, is to have an historical article in every Newsletter.

The Treasurer's Report was accepted as presented.

Bill Lydecker, Genealogical Chair, noted that genealogical information is being placed on computer as members send this information in. He requested that members check census records in their area of the country, and send this information to him, so that he can pass it on to Association Genealogist, Albert Stokes.

Albert Stokes reported that he is nearly through the Coert Line of the 5th generation, and he displayed an 18th century hand-made shawl, with fancy needlework, such as one of our female ancestors would have worn to church.

George Davis, Newsletter Editor, appealed to the membership to send in items of interest. He noted, for example, that the Newsletter will contain the recipes for the delicious Dutch food enjoyed at lunch, today.

Steve Shyers, Planning Committee member, requested that members send in their family charts, even if they are not complete. He noted that, sometimes, the charts can be completed through the information supplied by someone else's chart.

Bob Voris, Publications Chair, noted that we still have some copies of Vol. I of the genealogy for sale, and that we are looking forward to publishing the results of the recent Dutch research that we hired done. He thanked Hazel Voris for completing an Index to Vol. I, and said that she has volunteered to index Vol II, as well. He reported that the Vol I Index will be printed shortly and distributed to all of those who purchased Vol I, along with a request for a donation.

June Wick, Publicity Chair, asked for suggestions from the membership as to where to advertise our Association, in order to reach a general readership.

Prisident Vorhis then called on Elizabeth Edgar, in Cornelia Mason's absence, to present the Nominating Committee's recommendation for Vice President, which office is up for election this year. The name of Arthur Voorhees was put forth, and with no nominations forthcoming from the floor, Arthur Voorhees was duly re-elected to the post of Vice President. The Secretary noted that a total of 29 absentee ballots had been received, all unanimous in their support for Arthur Voorhees.

Several sites were suggested for next year's annual meeting, among them today's venue, some historical site in Bergen County, and Rutgers University. The feasibility of these sites will be explored, and a recommendation made at the next Executive Committee Meeting. No formal vote was taken.

Scott Voorhees, Program Chair, noted that there will be a punch reception after today's meeting, and that Steve Shyers will present a computer demonstration of how membership information is being stored. Bill Lydecker will also present a slide show of an 1888 trip to Holland.

Scott also mentioned that Drs. Jan Folkerts, our researcher in Holland, will be in this country next Fall, and has indicated that he is interested in being our annual speaker. Unfortunately, the meeting will have to be moved up one to two weeks in order to accomodate his itinerary. The membership informally agreed to the change of date, and an announcement of the time and place will be made in the Newsletter.

Scott then introduced our speaker, Harriet Stryker-Rodda, who was the first Certified Professional Genealogist in the State of NJ. Her topic was "You" -- as the link between past and future, as a unique source of valuable genealogical information which may well provide the only clues available to future generations. noted the importance of identifying pictures and family heirlooms, and of leaving some kind of a record of what you know about your family.

Before the meeting closed, Steve Shyers asked the membership about their interest in blazer patches and/or caps with the Van Voorhees coat-of-arms emblazoned on them. By a show of hands, the members indicated that they were interested in the blazer patches, but not in the caps; and Steve said he will look into this.

A benediction was given by the Rev. David Muyskens, pastor of the church; and the meeting was adjourned at 3:30 p.m.

ANNUAL MEETING

In recent years, the Association has held its Annual meeting in the New Brunswick/ Somerset, NJ area. This year's meeting will be a change in location, albeit a minor one, to Hackensack, in Bergen County, NJ.

The Van Voorhees family had an early and continuing connection to Hackensack and the surrounding area. Two of Steven Koerts' children settled there (Albert Stevense before 1686, and Hendrickje Stevense (Terhuyne) ca. 1689).

The meeting will be held in the historic "Church on the Green", the First Reformed Church of Hackensack, opposite the Bergen County Courthouse. The earliest records of the church date from 1686, making this the second oldest organized congregation in New Jersey. The original church was erected at this site in 1696.

In addition to the change in location, this year's Annual Meeting promises to be well worth the trip for two reasons.

The first is that the guest speaker will be Drs. Jan Folkerts, who will be in the United States doing research under the auspices of the Holland Society. As you have read in recent Newsletters, and elsewhere in this issue, Drs. Folkerts has recently completed a most successful research of the Netherlands archives for the Association. Drs. Folkerts' talk will be based on the results of that investigation. A question - and - answer period will follow the prepared talk.

In addition, in response to member requests, the Annual Meeting format has been extended to two days. Additional activities will include opportunities for genealogical exchange, and a tour of historic homes in the area on Sunday. Many of the homes to be visited have Van Voorhees family connections. The house tour will be informal, with transportation to the various sites to be provided by the members (no transportation arrangements will be made by the Association). Directions to the sites will be provided at Saturday's meeting. However, please note that a number of the sites are not normally open to the public on Sundays, and special arrangements are being made so that our members can visit on Sunday. It is imperative that you indicate on your meeting reservation if you will take advantage of the historic house tour, so that the necessary arrangements can be concluded.

Also, a number of the historic churches of various denominations in the area have been contacted, and will welcome our members to join in Sunday worship as well as visiting later in the day.

As an added bonus, the Old Bergen Chapter and History & Traditions Committee of the Holland Society, and the Friends of the New Netherlands Project are sponsoring a dinner on Saturday evening at the Inwood Manor in nearby Teaneck, NJ. The guest

speaker will be Dr. Charles Gehring, chief translator for the New Netherlands Project. His topic will be Peter Stuyvesant, based on the new information which has come to light as a result of the New Netherlands Project. Cost of the dinner is \$30 /person or \$55 /couple. About our speaker

Drs. Jan Folkerts was born in Zaltbommel, Guelderland in 1953. He studied journalism in Utrecht and history at the University of Groningen. As a historian, he published articles on New Netherland and Dutch New York in various Dutch historical periodicals. His main subject of research is agriculture in seventeenth century Dutch New York. He has been associated with the State Archives in Drenthe and Groningen, and is presently an archivist at the State Archives in Overijssel at Zwolle.


Members interested in swapping genealogical information should meet at the Church on the green, Saturday morning at 11:00.
