DRENTHE IN THE DUTCH REPUBLIC

ed. note: The following are the comments made by Drs. Jan Folkerts at Assen, to the travelers on the Van Voorhees Heritage Tour in October 1991.

Today, ladies and gentlemen, you won't see any spectacular remains of Dutch history and culture in the seventeenth century. What did Drenthe look like when your ancestors left the province in the year 1660?

To get a good idea of Drenthe in those times you will not only have to use your eyes but also your imagination.

There are a few general notions I would like to tell you about, before starting our program today. In the first place: try for one day to forget about "the" Dutch Republic. There was a huge contrast between the poor sandy regions in the east and the wealthy towns and seaports in the provinces of Holland and Zeeland.

The Dutch Republic was a federation of seven republics, that shared their defense and foreign policy. In almost all other respects they were independent. These seven republics were Holland, Zeeland, Utrecht, Friesland, Groningen, Guelderland and Overijssel. Of these seven republics, Holland was by far the most important, as it paid 58% of all national taxes. Where does this leave Drenthe?

If you listened to me carefully, you will have noticed that I didn't mention Drenthe among the seven republics. How about this region? Was it part of another province? No, it wasn't. Then, wasn't it independent like the others? Drenthe was autonomous in the same respects as the others, just one thing was different: Drenthe was the most thinly populated and the poorest of the provinces, and that is why it was simply denied its rightful place in the country's general assembly: the States-General. As I said before, the wealthiest province of the Dutch Republic paid 58% of all taxes, Drenthe on the contrary, paid only 1%. An eighth voice in the governing bodies of the Dutch Republic gave the problem of how to get a majority, an assembly of seven provinces was easier to dominate by the rich province of Holland.

For modern observers, it is easy to overestimate the more modern aspects of the way the Dutch Republic was governed. It is good to remember that in many respects the Dutch revolt against the Habsburgs was an effort to safeguard old and revered privileges. So on the local and regional levels many things stayed as they were since medieval times. The sources of real power in this republic were the town councils and provincial assemblies.

To summarize: Drenthe was not one of the seven allied provinces, but it formed an integral part of the Dutch Republic. It was autonomous in many ways like the others, and for instance, the

deputies of Drenthe independently signed the Union of Utecht, which formed the basis for the alliance against Spain. Like the others, in times of war and later after national independence definitely was established by the Peace of Munster in 1648, Drenthe held on to its old custons and institutions.

Since the eleventh century, Drenthe had formed a part of the territory of the bishops of Utrecht, but time and again the freedom-loving people of Drenthe tried to assert their independence. In a famous battle on the 27th of July, 1227, near the village of Ane on the border with Overijssel, the peasants of Drenthe defeated a mighty army of Bishop Otto. The Bishop and many of his noble followers were killed.

How was Drenthe governed in these centuries?

On the local level, the owners of a so-called "full" farm were almighty. Together they formed the "buurschap" or neighborhood. As there were only few large proprietors in Drenthe, this system was almost democratic, anybody with a complete farm of his own, had a voice in politics. Apart from this, we should not forget that the nobility of Drenthe was very small and had not very much influence.

In fact, it was a little wonder, that during the period of the Dutch Republic the nobility had a equal voice in politics with the so called "eigenerfden" or farmers. In the eighteenth century there were fewer than 10 noble families in Drenthe.

The highest governing body was the "landdag", or Diet: the provincial assembly, in which every parish sent its delegates. Even in the 17th century, they sometimes assembled in the open air.

The highest judicial body was the old "Etstoel". Each of the six districts or "dingspillen" of Drenthe had 4 representatives in this body, so in all there were 24 "etten" or judges, who almost always lacked every kind of formal training in law. Law was one of the key points in Drenthe's autonomy.

Since the Middle Ages, Drenthe had its own law, the famous "landrecht", which stayed intact until the early 19th century when French laws were adopted.

At the local level, autonomy also was almost complete. Every village was entitled to make its own laws without interference of the provincial government. If I use the word provincial, it is good to realize that the people of Drenthe carefully avoided this word. Drenthe was not a province in their eyes, it was the "landschap", literally the land of Drenthe. Some parts of Drenthe and some parishes were not represented in the governing assembly, the landdag or Diet. Among those were Ruinen and Ruinerwold. You know that these two parishes formed a small country of their own the manor of Ruinen. This situation continued until 1654, when the manor of Ruinen was consolidated with Drenthe.

HISTORICAL COMMITTEE

STEPHEN VOORHEES, Co. K, 14th NJ Regiment

Among the papers of is an original Association certificate, measuring approximately 17 inches by 15 inches, of Honorable Testimonial awarded to Stephen Voorhees, Company K, 14th New Jersey Regiment and dated July 4, 1866. The certificate is not in good condition. Somewhere in its travels, it was ripped in half, taped together and "nibbled" across the right

and top sides. Nonetheless, it has survived and can be framed as a family commemoration. belongs with the descendants of Stephen Voorhees. If any member of the Association is from descended Stephen wishes to have the certificate, please write to Manning Voorhees with your line from Stephen. In the case multiple requests, the earliest postmark will be considered first.

Book Review (Manning Voorhees)

Dr. Firth Haring Fabend has written a fascinating book about the development of the Haring family from 1662 to just after the Revolutionary War. The story commences with the marriage of John Pietersen Haring, parents whose had emigrated from Hoorn, the Netherlands, in the 1630's, and Grietje Cosyns, who was born on Manhattan Island in 1641 of Dutch emigres. Subsequently, the family joined the patentees of the Tappan Pattent, which now straddles the New Jersey-New York border, and became farmers and property owners in a virgin woodland. Dr. Fabend traces the development of a closely knit family as they slowly weakened their old Dutch ways and became Anglicized and eventually Americanized. However, while the descendants of John and Grietje gradually different adopted economic, testamentary, social and political standards, they still clung to elements of mid-17th century Dutch customs. schism that occurred within the Dutch Reformed Church affected did family. as Revolutionary War. There is no mention of the Van Voorhees family. Nonetheless,

forces that influenced the development of the Haring family presumably also affected the development of our family. I recommend the book for your enjoyment.

IN MEMORIAM

Dr. Arthur B. Voorhees, Jr., died May 12, 1992 at his home in Albuquerque, NM. Dr. Voorhees was 70. An accidental laboratory discovery when Dr. Voorhees was an intern, led to his development and implanting of the first successful artificial arteries for human patients. His earliest attempts used silk handkerchiefs and war-surplus parachute cloth to fabricate cloth arteries for animals. The same basic procedure used by Dr. Voorhees in 1952 remains in use today for replacement of blocked, ruptured or otherwise defective vascular tissue. Dr. Voorhees was born in Moorestown, NJ, graduated from the University of Virginia and Columbia College of Physicians and Surgeons. He was attending physician at Columbia Presbyterian Hospital for about 30 years, retiring as chief of the vascular service. He also taught at the College of Physicians and Surgeons.

Dr. Voorhees is survived by his wife, Margaret Roberts Voorhees, sons Stephen C. and Jefferson, daughter Evelyn L. Wade, sister Margaret Beal, and a granddaughter.

Sam Vorhies, age 88, died on April 25, 1992. His sister, Winona Vorhies Hillman, age 94, died on June 10, 1992. Sam and Winona were two of four brothers and sisters left from a family of fourteen children of Edgar and Della Vorhies. They were born and lived in Henry Co., IA.

Laurence G. Cramer of Park Ridge IL, died November 12, 1991. He is survived by his wife Rose, son Laurence G., Jr., 2 daughters and 5 grandchildren.

Col. Frederick H. Field of Far Hills, NJ, died October 5, 1991.

Marilyn G. Owen died on October 17, 1991. Born January 14, 1924, the daughter of Charles J. and Blanche Knott Unseld at Clairton, PA. A long-time resident of Manhattan Beach, CA, Mrs. Owen was a retired Los Angeles Policewoman, and lecturer in English at Cal State University. Mrs. Owen is survived by her husband Charles N., son Joseph G., step-son Richard, grandsons and step-grandchildren.

- 4. Scott thinks the Association should have a balanced budget (pay your dues).


